On the home page, the three images under featured courses have alt text that is redundant to the link text. The alt text should be set to null. The Search icon in the navigation bar does not have a text alternative. On the Authors page and each individual author's page, the icon image or portrait image next to each author's name is redundant, but is not hidden to assistive technology. On the individual course pages, the checkbox icons next to each video do not have a text alternative. Upon opening the Add to Playlist menu for a course, there is a list of the user's playlists with a checkbox icon next to each. The icon does not have a text alternative that describes its purpose. On the page containing details for individual playlists, the (x) icons do not have a text alternative. On the Search page, the search button with the magnifying glass icon does not have an accessible name, which would act as the text alternative.

1.3.1 Info and Relationships (Level A)	Partially Supports	 On the Playlists page, the New Playlist dialog visually appears as a modal dialog, but is not given correct ARIA semantics or keyboard focus management. The same is true with the Remove Playlist dialog found on the page containing details for individual playlists. On the page containing details for individual playlists, the (x) icons behave as buttons but there are no semantics indicated for assistive technology (nor keyboard functionality). Upon opening the Add to Playlist menu for a course, there is a list of the user's playlists with a checkbox icon next to each. The list items behave like checkboxes, but are coded as links instead. On individual course pages, the interactive headings behave as buttons but are communicated as links that do not go to anywhere. On the Terms of Service page, the "Online Training Library Terms of Use" text should be marked up as a heading. On the Terms of Service page, the numbered

		 list is not marked up as such. On the search page, when a search returns no results, the search term is differentiated by color, but this emphasis is not indicated programmatically. In the video player, there is a playback speed submenu and captions submenu on some videos. A checkmark icon indicates the currently selected menu option, but this is not indicated programmatically.

1.3.3 Sensory Characteristics (Level A)	Supports	In the Video Training Library, instructions for operating content do not solely rely on sensory characteristics.
1.4.1 Use of Color (Level A)	Partially Supports	 Hyperlinks within the main body content and footer are distinguished only by a difference in color. It does not have additional indication such as sufficient contrast with the body text or an underline. It is not clear they are links. On individual course pages, the accordion headers are only distinguished from the regular headers by color. On the search page, when a search returns no results, the search term is differentiated by color, but does not include a secondary indicator.

4.1.2 Name, Role, Value (Level A)	Partially Supports	 The navigation menu dropdowns lack default aria-expanded attributes, meaning the dropdown semantics are not communicated when first encountered. On individual course pages, the interactive headings lack a default aria-expanded attribute, meaning the collapse/expand behavior is not communicated semantically. On the Playlists page, the Add Playlist control acts as a button that opens a dialog, but is coded as a link. Unlike navigation, it is not in a location where links elements are implied.

On the search page, when a search returns no results, the search term is differentiated by color, but this color does not pass contrast with the white page background. The video player has a semi-transparent background within its submenus, which cannot guarantee text contrast for submenu

In the video player, some custom tooltips and menus can get cut off under the width constraints of the criterion.
1.4.11 Non-text Contrast (Level AA 2.1 and 2.2)	Partially Supports	 The magnifying glass icon for search does not pass contrast with the dark navbar background. The primary button theme, which is blue, has a focus indicator that does not pass contrast with the white page background. The secondary button theme, which is dark grey, has a focus indicator that does not pass contrast with the white page background. The default form input color of light grey does not pass contrast with the white page background. The mouse focus indicator for the Add to Playlist dropdown options does not pass

		contrast with the surrounding white background. The magnifying glass icon inside the search button on the search page does not pass contrast with the green button background. It's focus indicator also does not pass contrast with the white page background.
